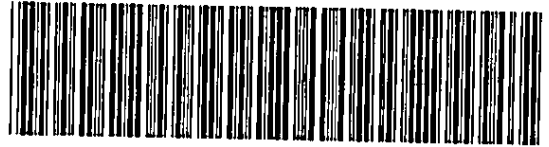

We spoke on the phone last week and you said that I could overnight a new packet to Revoke my Voluntary Dissolution since it appears to have been lost.


I am enclosing the tracking number which shows that it was received on April 13, 2022. Your website states that you have already processed past this date therefore I am convinced that it is lost.
