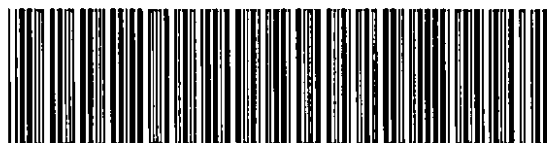

**ARTICLES OF INCORPORATION
OF
David Kurlander Attorney at Law P.A.**

In compliance with the requirements of the Florida Business Corporation Act (the "FBCA") [and the Professional Service Corporation and Limited Liability Company Act], the undersigned hereby acts as an incorporator in adopting and filing these Articles of Incorporation.

ARTICLE I: NAME

The name of the corporation shall be David Kurlander Attorney at Law P.A. (the "Corporation").

ARTICLE II: INITIAL PRINCIPAL OFFICE

The street address of the initial principal office of the Corporation is 5301 N. Federal Highway, Suite 380, Boca Raton, FL 33487.

[ARTICLE III: PURPOSE

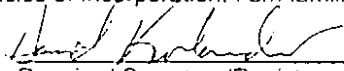
ARTICLE X: INDEMNIFICATION OF DIRECTORS AND OFFICERS

Any amendment, repeal, or modification of this Article X shall not adversely affect any right or protection hereunder of any person in respect of any act or omission occurring prior to the time of such repeal or modification.

ARTICLE XII: EFFECTIVE DATE AND TIME

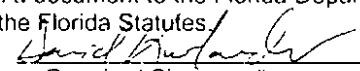
