## ARTICLES OF AMENDMENT TO ARTICLES OF INCORPORATION OF DIGITAL SILK INC

Pursuant to the provisions of §607.1006 of the Florida Business Corporation Act (the "Act"). **DIGITAL SILK INC**, a Florida Profit Corporation (the "Corporation"), document number P19000035764, has adopted the following amendment to its Articles of Incorporation:

1. The Corporation's Articles of Incorporation are hereby amended by deleting Article IV in its entirety and substituting, in lieu thereof, a new Article IV, as follows:

### "ARTICLE IV

The total authorized capital stock of the Corporation shall consist of One Hundred (100) shares of Class A Voting Common Stock, par value of \$.01 per share (the "Class A Common Stock"), and Nine Thousand Nine Hundred (9,900) shares of Class B Non-Voting Common Stock, par value \$.01 per share (the "Class B Common Stock"). The Class A Common Stock and the Class B Common Stock are hereinafter sometimes collectively referred to as "Common Stock." The voting power for the election of directors and all other purposes shall be vested exclusively in the holders of Class A Common Stock, and except as otherwise required by law, the holders of Class B Common Stock shall not have any voting power or be entitled to receive any notice of meetings of stockholders. Each share of Class A Common Stock outstanding on any record date shall be entitled to one vote."

- 2. Except as hereby amended, the Articles of Incorporation of the Corporation shall remain the same.
- 4. In accordance with §607.0123(1)(a) of the Act, this amendment shall be effective as of the date of the filing of this amendment with the Florida Department of State.
