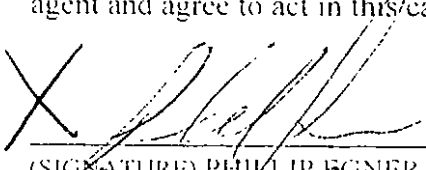

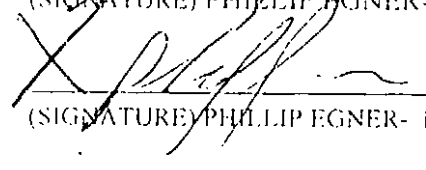

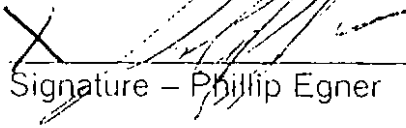

1. Introduction. Phillip Egner, being duly sworn, deposes and says:

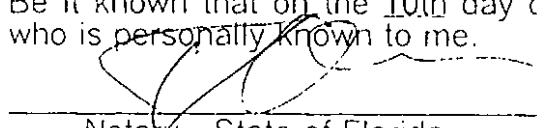
