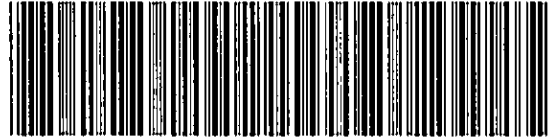

The undersigned, for the purposes of forming a corporation under the Florida General Corporation Act, do hereby adopt the following articles of Dissolution:


Article One:
