**ARTICLES OF INCORPORATION
OF

We, the undersigned, hereby associate ourselves together for the purpose of becoming a corporation under the laws of the State of Florida. Providing for the formation, rights, privileges, immunities, and liabilities of incorporation for profit.

ARTICLE I

The name of the corporation should be:

The maximum number of shares, which the corporation is authorized to issue and have outstanding at any one time, is **100** shares of common stock, one dollar (\$1.00) par value.
All stock is to be issued as fully paid and exempt from assessment.




