ARTICLE I - NAME

The name of this corporation shall be:

ARTICLE II - NATURE OF BUSINESS

This corporation may engage in the transaction of any and all activities permitted under the Laws of the State of Florida and the United States of America, under Chapter 621 professional services, for the purpose of engaging in every aspect of the practice of Dentistry.

ARTICLE III - SHARES

The maximum number of shares of stock that this corporation is authorized to issue at any time is 100 Shares
common non par value shares.

ARTICLE IV - TERM OF EXISTENCE

The corporation shall exist perpetually unless dissolved sooner according to law.

ARTICLE V - PRINCIPAL OFFICE

The rights accruing to any person under the forgoing provision shall not exclude any right to which he may be lawfully entitled nor shall any herein contained restrict the right of the corporation indemnified reimburse such person in any proper case even though not specifically herein provided for.



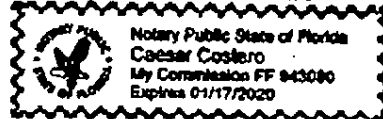
