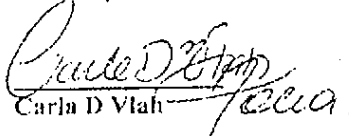

Thank you for your attention and I hope you can help at this matter and is possible register my new corporation.

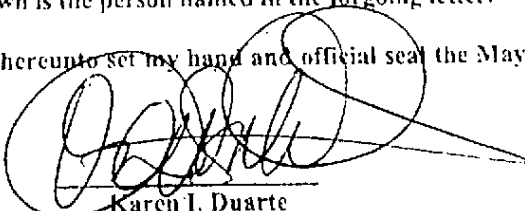
