ARTICLES OF INCORPORATION OF AUTOMATION, LIGHT, & MAGIC, INC.

The undersigned acting as sole Incorporator and Initial Director of <u>AUTOMATION, LIGHT, & MAGIC, INC.</u>, under the Florida Business Corporations Act, adopts the following Articles of Incorporation:

ARTICLE 1 - NAME

Prompt notice of the taking of the corporate action without a meeting by less than unanimous written consent shall be given to shareholders who have not consented in writing or who are not entitled to vote on the action. Any action required or permitted by law to be taken at a board of directors' meeting or committee meeting may be taken without a meeting if the action is taken and consented to in writing by all the members of the board or committee.
