
## AFFIDAVIT



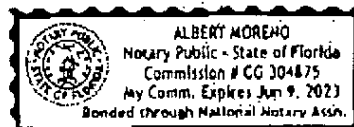

**ARTICLES OF AMENDMENT  
TO  
ARTICLES OF INCORPORATION OF  
IIPA, INC.**

1. The name of the corporation is IIPA, Inc.
2. Article I of the corporation's Articles of Incorporation is hereby deleted and replaced in its entirety with the following:

**"ARTICLE I.  
NAME**

The name of the corporation is Informed Independent Physician Association, Inc."

3. These Articles of Amendment were unanimously adopted by the board of directors of the corporation and the sole shareholder of the corporation on July 12, 2019, by written consent, pursuant to the Florida Business Corporation Act.
4. The number of votes cast by the sole shareholder of the corporation was sufficient for approval.
5. These Articles of Amendment shall become effective upon filing with the Secretary of State of the state of Florida.
