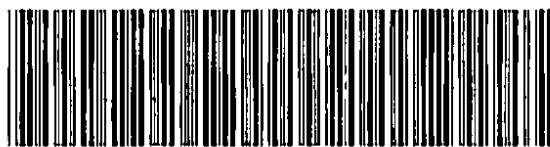

I, **THE UNDERSIGNED**, do hereby execute these Articles of Incorporation for the purposes of forming and becoming a corporation for profit in compliance with Chapter 607, F.S., and do hereby certify that I have become such a corporation under and pursuant to the following Articles of Incorporation.




