**ARTICLES OF INCORPORATION
OF

A Florida Profit Corporation**

The undersigned, for the purpose of forming a profit corporation under the Chapter 607, Florida Statutes, hereby makes, acknowledges, and files these Articles of Incorporation.

ARTICLE I

The name of the corporation is MOA TREE SERVICE INC. (the "Corporation")

ARTICLE II

The mailing address and address of the principal office of the Corporation shall be:

ARTICLE III

The period of duration of the Corporation shall be perpetual unless dissolved according to law.

ARTICLE IV

The Corporation is organized for the purpose of engaging in any and all lawful business for which corporations may be incorporated under Chapter 607, Florida Statutes, as amended.

ARTICLE V

The Corporation is authorized to issue Ten Thousand (10,000) shares of common stock with a par value of \$1.00 per share. All stock shall be of one class. The Board of Directors may authorize the issuance of such stock to such person(s), upon such terms, and for such consideration as they may deem appropriate. The consideration may consist of any tangible or intangible property or benefit to the Corporation, including cash, promissory notes, services performed, promises to perform services evidenced by a written contract, or other securities of the Corporation.

The Corporation elects to have preemptive rights. Every shareholder, upon sale for cash of any new or reissued stock of the Corporation, shall have the right to purchase his or her pro-rata share thereof at the price at which it is offered to others.


