ARTICLES OF INCORPORATION

OF

S.E.E.R.S. QUALITY AIR CONDITIONING CORPORATION, INTEG

The undersigned, acting as incorporator of a corporation under the Flatta General Corporation Act, adopts the following Articles of Incorporation for such corporation:

ARTICLE I - NAME

The name of the corporation is S.E.E.R.S. Quality Air Conditioning Corporation, Inc.

ARTICLE II - TERM OF EXISTENCE

The period of duration of the corporation is **perpetual**.

ARTICLE III - NATURE OF BUSINESS

This corporation is organized for the purpose of sales, installation, service of air conditioners, and any other business activity permitted and any other activity or business permitted under the laws of the United States and the State of Florida.

ARTICLE IV - AUTHORIZED SHARES

The holders of the outstanding capital stock shall be entitled to receive, when and as declared by the Board of Directors, dividends payable either in cash, in property, or in shares of the capital stock of the corporation. The shares of the corporation are not to be divided into classes, and the corporation is not authorized to issue shares in series.

ARTICLE V - INITIAL REGISTERED OFFICE AND AGENT

The principal place of business of the corporation is located in Duval County. Florida, and the address is 5460 Keystone Drive. North. Jacksonville. FL 32207. The name of the initial registered agent is Arnaldo Borroto, and the initial registered office is 5460 Keystone Drive. North, Jacksonville, FL 32207.

ARTICLE VI - DIRECTORS

The initial Board of Directors shall consist of **one (1) member** who need not be a resident of the State of Florida or a shareholder of the corporation.

ARTICLE VII - INITIAL DIRECTORS

ARTICLE X - CUMULATIVE VOTING

The shareholder of the corporation shall be allowed to vote his shares cumulatively so as to give one candidate as many votes as the number of directors to be elected, multiplied by the number of his shares, to distribute them among as many candidates as he may wish. Notice must be given by any shareholder to the President or a Vice-President of said corporation not less than twenty-four (24) hours prior to the time set for the holding of a shareholders' meeting for the election of directors that said shareholder intends to cumulate his vote at said election.

ARTICLE XI - SECTION 1244

This corporation and the **shareholder** hereof shall be subject to Section 1244 of the United States Internal Revenue Code.
