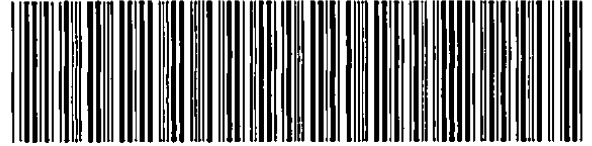

Registered Agent

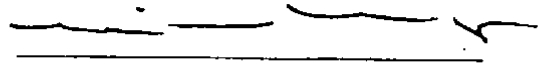
