

# ARTICLES OF INCORPORATION

OF

# MAGIC TRANSPORTATION GROUP, INC.

The undersigned, acting as the Incorporator of Magic Transportation Group, Inc., a Florida corporation (the "Corporation"), pursuant to Chapter 607 of the Florida Statutes, hereby forms a corporation for profit under the laws of the State of Florida and adopts the following Articles of Incorporation for the Corporation:

#### ARTICLE I - NAME

The name of the Corporation is Magic Transportation Group, Inc. The street address of the initial principal office of the Corporation and mailing address shall be 1702 Waterwitch Drive, Orlando Florida 32806.

## ARTICLE II - CORPORATE EXISTENCE

The Corporation will exist commencing on the date of filing these Articles of Incorporation with the Florida Department of State.

#### ARTICLE M - DURATION

The Corporation shall exist perpetually.

#### **ARTICLE IV - PURPOSE**

The Corporation is organized for the purpose of transacting any or all lawful businesses for which corporations may be incorporated under Chapter 607, Florida Statutes.

## ARTICLE V - CAPITAL STOCK
