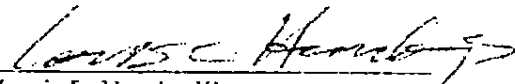
ARTICLE VIII – DIRECTORS AND OFFICERS

ARTICLE IX - INDEMNIFICATION

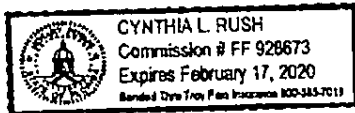

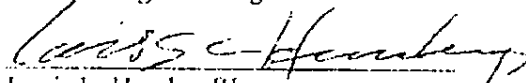
