The undersigned, acting as the incorporator of Ferman on Dale Mabry, Inc., under the Florida Business Corporation Act, adopts the following Articles of Incorporation:

ARTICLE I. NAME

The name of the corporation is Ferman on Dale Mabry, Inc. (the "Corporation").

ARTICLE II. PRINCIPAL OFFICE AND MAILING ADDRESS

The initial principal business office and mailing address of the Corporation is 1306 West Kennedy Boulevard, Tampa, Florida 33606.


ARTICLE V. INCORPORATOR
