No Classes of Stock: The shares of the Corporation are not to be divided into classes.

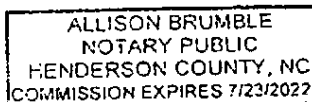


