ARTICLES OF INCORPORATION of DESI HOLDINGS, INC.

ARTICLE I NAME

The name of the Corporation is DESI Holdings, Inc.

ARTICLE II PRINCIPAL OFFICE AND MAILING ADDRESS

The principal office and mailing address of the Corporation is located at 9595 Sunbeam Center Drive, Jacksonville, Florida 32257.

ARTICLE III PURPOSE

The Corporation's purpose shall be for any and all lawful business.

ARTICLE IV CAPITAL STOCK

- (a) Authorized Shares. The total number of shares of stock that the Corporation may issue is 100 shares with a par value of \$0.10 per share. Each of the shares shall entitle the holder thereof to one (1) vote at any meeting of the shareholders. All or any part of the stock may be paid for in cash or in property at a fair valuation to be fixed by the Board of Directors at a meeting called for such purpose. All stock, when issued, shall be fully paid and nonassessable.
- (b) <u>Capital Stock</u>. The capital of the Corporation shall be at least equal to the sum of the aggregate par value of all issued shares baving par value plus such amounts as, from time to time, by resolution of the Board of Directors, may be transferred thereto.
- (c) <u>Corporate Liquidation and Dissolution</u>. In the event of voluntary or involuntary liquidation, dissolution or winding up of the Corporation, the holders of record of the common stock shall be entitled to receive distribution, ratably, of the remaining assets of the Corporation.
 - (d) <u>Preemptive Rights</u>. Shareholders shall have no preemptive rights.
 - (e) <u>Cumulative Voting</u>. Cumulative voting shall not be permitted.
- (f) Restrictions on Transfer of Stock. The shareholders may, by bylaw provision or by a shareholders' agreement recorded in the Corporation's minute book, impose such

restrictions on the sale, transfer, or encumbrance of the stock of the Corporation as they may see fit.
