# ARTICLES OF INCORPORATION OF PALM BEACH PRESTIGE REALTY, P.A.

#### Article I <u>Name</u>

The name of this corporation is PALM BEACH PRESTIGE REALTY, P.A. The effective date of filing shall be July 22, 2019.

## Article II Principal Office Address

#### Article III Nature of Business

This Professional Corporation is being formed for the following purposes:

- a. To engage in any and all lawful business or activity permitted under the laws of the United States and the State of Florida, as engaged in by licensed real estate broker.
- b. To generally have and exercise all powers, rights and privileges necessary and incident to carrying out properly the objects herein mentioned.
- c.
