# ARTICLES OF INCORPORATION

OF

#### SL CONSTRUCTION SERVICE & SALE, INC.

THESE ARTICLES OF INCORPORATION are hereby adopted by the undersigned incorporator(s) of this corporation for pecuniary profit under the Florida Business Corporation Act.

#### ARTICLE I.

## NAME AND LOCATION OF AGENT AND OFFICES

# SECTION 1.1 NAME:

The name of the corporation shall be SL CONSTRUCTION SERVICE & SALE, INC.

## SECTION 1.2 PRINCIPAL OFFICE or MAILING ADDRESS:

The principal office or mailing address of the corporation shall be 10802 PRESERVATION VIEW DRIVE #102, TAMPA, FL 33626. The corporation may change the forgoing addresses, transact business at other places within or without the State of Florida and establish branch offices within or without the State of Florida, all as the Board of Directors may from time to time determined.

# SECTION 1.3 INITIAL REGISTERED AGENT AND OFFICE: STATEMENT OF ACCEPTANCE:

## SECTION 2.1 DURATION:

The shares of stock authorized hereunder shall not be divided into classes and shall consist of one class of common stock only. The aggregate number of shares of stock which the corporation shall be authorized to issue and have outstanding at any one time shall be limited to ONE THOUSAND (1,000) shares at One Dollar(\$1.00) par value. These shares shall have unlimited voting rights and are entitled to receive the net assets of the corporation upon dissolution.

#### **SECTION 4.2** CONSIDERATION:

The consideration for the issuance of said shares, or any part thereof, shall be money current of the United States of America, or property or services of value at least equivalent to the stock issued as fixed and determined by the Board of Directors of said corporation. ## **SECTION 4.3** NO PREEMPTIVE RIGHTS:

The directors calling the meeting shall give three (3) days' advance written notice of the time and place of the meeting to each director.

#### SECTION 5.3 INITIAL DIRECTORS:

The number of directors constituting the initial Board of Directors shall be one (1), which number may be increased or decreased but not below one(1) from time to time in accordance with the Bylaws.
