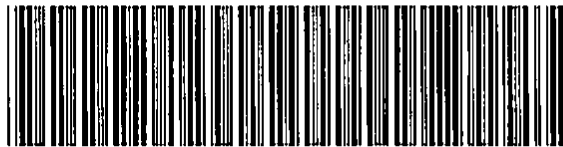

ARTICLE IX

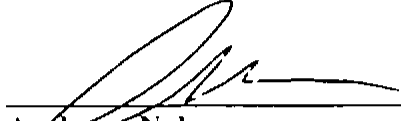

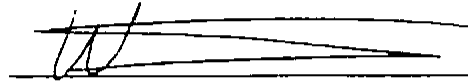
