FINAL ORDER DISSOLVING CORPORATION

This matter came before the Court upon the Complaint for Order Dissolving Florida Corporation filed by the OFFICE OF THE ATTORNEY GENERAL. STATE OF FLORIDA, DEPARTMENT OF LEGAL AFFAIRS. The Court, having considered the allegations of the complaint and the affidavit of Adele Stone filed therewith, finds as follows:

 Meadow Yaddy Corp filed Articles of Incorporation with the Florida Department of State, Division of Corporations on July 25, 2019 (the "Articles of Incorporation") and was assigned filing number P19000060460.

a hearing was kild by theyekon on 10/11/19 and alterny Robert Meek appeared for the alterny Green office.

- 2. The Articles of Incorporation reflect Adlele Stone as the incorporator, registered agent, sole officer/director at an address which was a former residence address for Adele Stone and reflect her electronic signature.
- 3. Adele Stone is not affiliated with Meadow Yaddy Corp, was not the incorporator, registered agent, or officer and the address listed as the mailing address and principal address of Meadow Yaddy Corp is not the principal address or mailing address for Meadow Yaddy Corp. Moreover, Adele Stone was unaware of Meadow Yaddy Corp. the filing of the Articles of Incorporation and did not authorize the use of her identity as incorporator, registered agent, officer/director or her signature or former residence address on the Articles of Incorporation.
- 4. Meadow Yaddy Corp obtained its articles of incorporation and corporate status through fraud.
- 5. This Court is authorized by Florida Statute 607.1430 (2019) in an action brought by the Department of Legal Affairs to dissolve a corporation which obtained its articles of incorporation through fraud.
- 6. Because of the fraudulent conduct of Meadow Yaddy Corp fraudulently using only information identifying Adele Stone as the incorporator, registered agent, sole officer/director and her former residence address as the principal address

and mailing address, there is no party or individual to give notice of this proceeding and an opportunity to be heard.
