#### <u>ARTICLE I - NAME</u>

The name of this corporation is AOI Solutions, Inc. located at 137 S. Courtenay Parkway, #423, Merritt Island, Florida 32952.

#### ARTICLE II - DURATION

This corporation shall have a perpetual existence commencing upon the filing of these Articles of Incorporation by the Department of State.

#### **ARTICLE III - PURPOSE**
