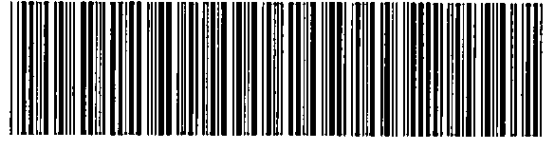

ARTICLE I. NAME

The name of this corporation is VINNIE'S INNOVATIVE PAINTING INC.


