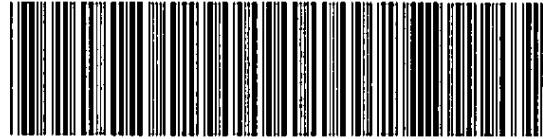



ARTICLES OF DISSOLUTION

Pursuant to section 607.1401, Florida Statutes, the Florida profit corporation submits the following articles of dissolution:

- FIRST: The name of the corporation currently filed with the Florida Department of State is MY CAREER TRANSFORMATION, INC.
- SECOND: The document number of the corporation is P19000062920.
- THIRD: The file date of the articles of incorporation is 8/09/2019.
- FOURTH: None of the corporation's shares have been issued.
- FIFTH: No debt of the corporation remains unpaid.
- SIXTH: Net assets have been distributed. The net assets of MCT after closing accounts and paying all debts were negligible. The intellectual property including the website, courses, and artwork were distributed to Keith Leust and Dan Morris.
- SEVENTH: The directors authorized the dissolution. On June 19th, 2020, the President gave proper notice to the directors of a Zoom meeting on June 26, 2020, at 10:00 am with the subject "Folding MCT" and purpose to consider a proposal to dissolve the corporation. On June 26, 2020, by resolution duly approved by the Board of Directors in the manner required by the 2019 Florida Business Corporation Act and by the articles of incorporation, a majority of the Directors authorized dissolution and directed the Treasurer to take all actions necessary to pay creditors, release authors, close accounts, and dissolve the Company.
