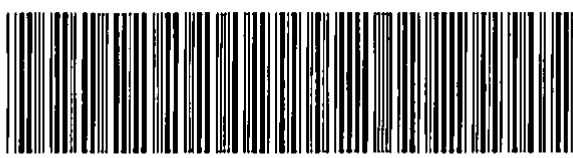

The undersigned, for the purpose of forming a professional corporation pursuant to Chapters 607 and 621 of the Florida Statutes, hereby makes, acknowledges and files the following Articles of Incorporation (the "Articles").

ARTICLE VII. INCORPORATOR

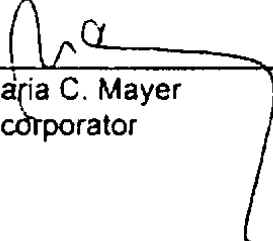

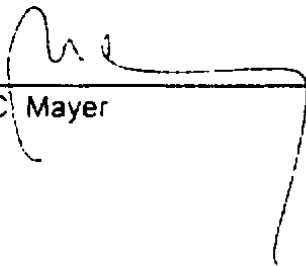
