**ARTICLES OF INCORPORATION
OF
RETYP GLOBAL, INC.**

In compliance with the requirements of the Florida Business Corporation Act (the "FBCA"), the undersigned hereby acts as an incorporator in adopting and filing these Articles of Incorporation:

ARTICLE I: NAME

The name of the corporation shall be RETYP GLOBAL, INC. (the "Corporation").

ARTICLE II: INITIAL PRINCIPAL OFFICE

The street and mailing address of the initial principal office of the Corporation is 7732 Maywood Crest Dr., West Palm Beach, Florida 33412.

ARTICLE III: PURPOSE

The Corporation is organized to transact any or all lawful business for which corporations may be incorporated under the FBCA as it now exists or may hereafter be amended or supplemented.

ARTICLE IV: SHARES

The total number of shares that the Corporation is authorized to issue and have outstanding at any time is 250,000, all of which shall be common stock with a par value of \$0.01 per share. The outstanding shares of common stock of the Corporation shall have a par value of \$2,500.
