The undersigned, acting as directors for the purpose of forming a corporation under and by virtue of the laws of the State of Florida, adopt the following Articles of Incorporation which shall take effect as of 11:58 p.m., Eastern Daylight Time, on August 31, 2019.

ARTICLE I

The name of the corporation shall be Fidelity Bank of Florida and its initial place of business shall be 1380 N. Courtenay Parkway, Merritt Island, Florida 32953.

ARTICLE II

This corporation is incorporated by conversion from a national banking association.

ARTICLE III

The general nature of the business to be transacted by this corporation shall be that of a general commercial banking business with all the rights, powers, and privileges granted and conferred by the Florida Financial Institutions Codes, regulating the organization, powers, and management of banking corporations.

ARTICLE IV
