ARTICLES OF INCORPORATION
OF
BAN TRANSFER, INC.

The undersigned, acting as incorporator of BAN TRANSFER, INC. under the Florida Business Corporation Act, adopts the following Articles of Incorporation.

ARTICLE I. NAME

The name of the corporation is BAN TRANSFER, INC. (the "Corporation").

ARTICLE II. ADDRESS

The principal and mailing address of the Corporation is:

ARTICLE III. COMMENCEMENT OF EXISTENCE

The existence of the Corporation will commence on the date of filing of these Articles of Incorporation.

ARTICLE IV. PURPOSE

The Corporation is organized to engage in any activity or business permitted under the laws of the United States and Florida.

ARTICLE V. AUTHORIZED SHARES

The maximum number of shares that the Corporation is authorized to have outstanding at any time is five hundred thousand (500,000) shares of common stock having \$0.01 par value per share. One hundred thousand (100,000) shares of the authorized shares shall be designated as "Common Stock" and four hundred thousand (400,000) shares of the authorized shares shall be designated as "Preferred Stock". The preferences, limitations and relative rights with respect to Common Stock and the Preferred Stock shall be the same, except that the holders of the Common Stock shall not be entitled to vote on any matters required or permitted to be submitted to a vote by the Shareholders of the Corporation, except when otherwise required by laws.

ARTICLE IX. BYLAWS

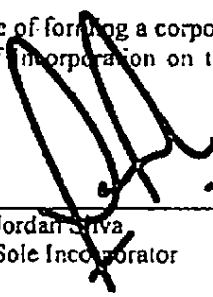
