ARTICLES OF INCORPORATION

OF

DESIGN 4 GROUP, P. A.

ARTICLE I - NAME

The name of the Corporation is Design 4 Group, P. A.

ARTICLE II - DURATION

The corporation shall have perpetual existence.

ARTICLE III - NATURE OF BUSINESS

(Special Purpose)

The special purpose for which this corporation is being organized shall include the practice of Licensed Real Estate Sales and services as a Licensed Real Estate Sales Corporation and to carry on services incident thereto, the practice of general licensed Real Estate Sales and Services is the sole and exclusive professional service to be rendered by this corporation.
