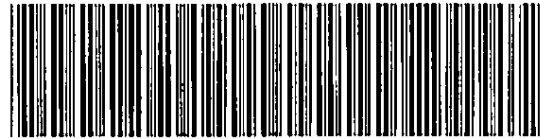

In accordance with the provisions of Florida Statutes Section 607.1006, **NETWIDOO USA CORP**, a Florida corporation, incorporated on August 29th, 2019, and assigned a Florida document number P19000069257 (the "Corporation"), hereby amends the Articles of Incorporation of the Corporation.

1. Article VII of the existing Articles of Incorporation of the Corporation, which relates to the original officers and/or directors of the Corporation, is hereby deleted in its entirety and the following new Article VII shall be inserted in lieu thereof:
