**ARTICLES OF INCORPORATION OF

The undersigned, for the purpose of forming a corporation under the Florida Business Corporation Act, do hereby adopt the following Articles of Incorporation:

**ARTICLE I**  
**NAME AND ADDRESS**

The name of the Corporation is Rucker's Resources, Inc. The principal office and mailing address of the Corporation is: 2925 18th Avenue SE, Naples, FL 34117.

**ARTICLE II: DURATION**

The duration of the Corporation is perpetual.

**ARTICLE III: PURPOSE**

The general purposes for which the Corporation is organized are the following:

- A. To engage in and transact any lawful business for which corporations may be incorporated under the Florida General Corporation Act. No other purpose limits this general purpose in any way.


