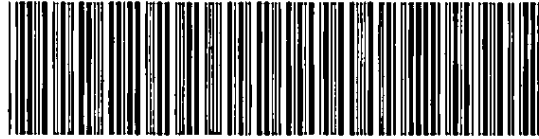

ARTICLES OF INCORPORATION
OF
ACE PLUMBING & DRAIN, INC.

In compliance with the requirements of Chapter 607, Florida Statutes, the undersigned, being a natural person, hereby acts as an incorporator in adopting and filing the following articles of incorporation for the purpose of organizing a business corporation.

ARTICLE I

The name of the Corporation ("Corporation") is ACE PLUMBING & DRAIN, INC.

ARTICLE II

The existence of the Corporation shall begin on THE DATE OF FILING OF THESE ARTICLES or September 1, 2019, whichever shall first occur..

ARTICLE III

The street address of the principal office of the Corporation is 606 Mills Avenue, Pensacola, Florida 32507.

ARTICLE IV

The maximum number of shares this Corporation is authorized to issue is ONE HUNDRED, par value \$.01 per share, all of which shall be Common Shares.
