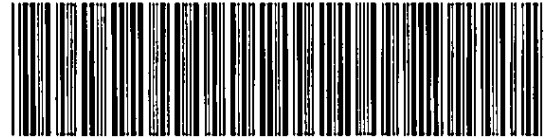



I
Name

Manner of Adoption


The amendment was duly approved by the written consent to action of the shareholders of the Corporation.
