- 5. <u>Marital Settlement Agreement</u>. Parties' Marital Settlement Agreement attached hereto as Exhibit "A" is ratified and made a part of this Final Judgment, but is not merged. The Parties are ordered to comply with all of provisions contained therein.

- 6. The Petitioner/Wife's maiden name is hereby restored. The Wife shall be known as "DIANA MARIA BERMUDEZ".
- 7. This Court reserves jurisdiction to enforce and to adjudicate all issues reserved or contemplated in the Parties' Marital Settlement Agreement, including but not limited to, accomplishing the transfer of all property and assets of the Parties, pursuant to the terms of the Parties' Marital Settlement Agreement and for entry of all Orders and/or Judgments for all purposes as provided by law.
