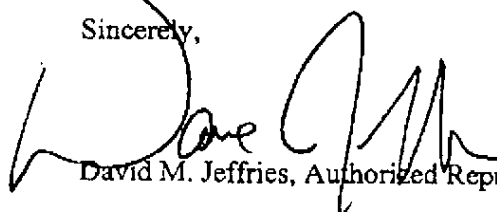

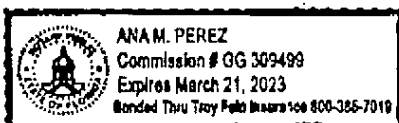

The undersigned, acting as incorporator of the captioned corporation under the Florida Business Corporation Act, adopts the following Articles of Incorporation:

ARTICLE I

Corporate Name and Principal Office

The name of this corporation is SureView Systems, Inc., and it maintains a physical and mailing address at 400 North Ashley Drive, Suite 1650, Tampa, Florida 33602.

Commencement and Term of Corporate Existence

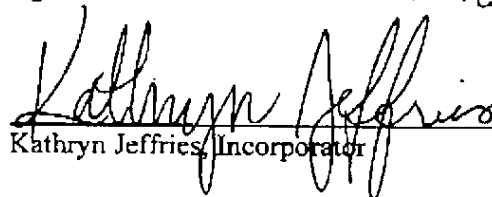
