The undersigned incorporator to these Articles of Incorporation, a person, competent to contract, hereby forms a Corporation under the laws of the State of Florida.

ARTICLE I.

NAME

The name of the Corporation shall be

PRINCIPAL OFFICE

ARTICLE III.

PURPOSES

The purpose for which the corporation is formed and the business objects to be carried on and promoted by it are as follows:

To transact any lawful business for which corporations may be incorporated under the Florida General Corporation Act.


