ARTICLES OF INCORPORATION OF ARG SERVICES, INC.

ARTICLE 1 NAME

The name of the corporation is ARG Services, Inc. (the "Corporation").

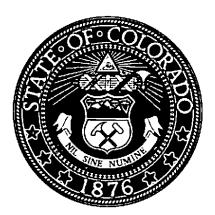
