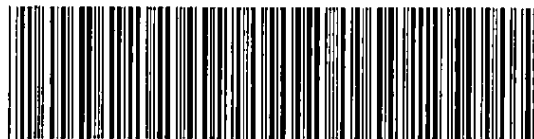

**ARTICLE 1  
NAME**

The name of the corporation is ARG Services, Inc. (the "Corporation").

**ARTICLE 2  
PRINCIPAL OFFICE**

The street address of the initial principal office of the Corporation is Three Glenlake Parkway NE, 5th Floor, Atlanta, Georgia 30328.

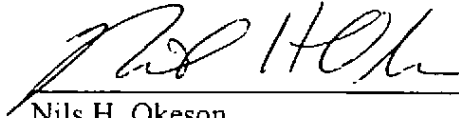
