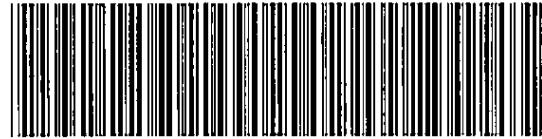

THE UNDERSIGNED hereby adopts and executes these Articles of Incorporation for the purposes of forming and becoming a corporation for profit under the Florida General Corporation Act pursuant to the following Articles of Incorporation.

ARTICLE I — NAME

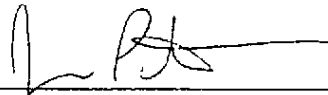
