**ARTICLE I**

The name of the Corporation ("Corporation") is "JAYDEN, INC."

**ARTICLE II**

The street address of the principal office and mailing address of the Corporation is 6580A, Crooked Creek Lane, St. Augustine, FL 32095.

**ARTICLE III**

The corporation is formed for the specific purpose of providing a trucking service for third-party vendors. The corporation may invest any funds in real estate, mortgages, stocks, bonds, or any other type of investment, and may own real and personal property necessary for the advancement of the corporation.

**ARTICLE IV**

The existence of the Corporation shall be perpetual and commence on September 28, 2019.

**ARTICLE V**

The maximum number of shares this Corporation is authorized to issue is Ten Thousand (10,000) shares of common stock having a par value of \$.01 per share, all of which shall be Common Shares.
