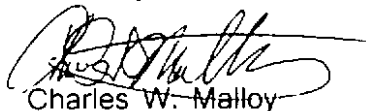

## **ARTICLE I NAME**

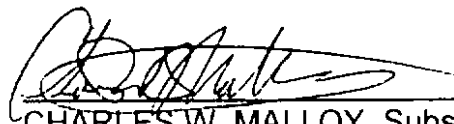
**ARTICLE X

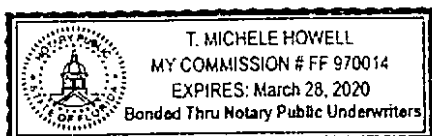
