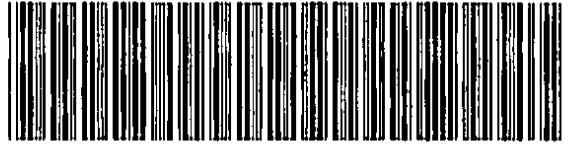

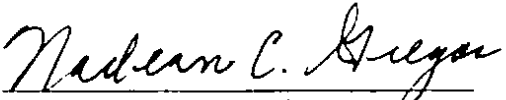
The name of the Corporation is CRU SALON INC., which was duly incorporated on October 14, 2019, by the State of Florida.
