**ARTICLES OF INCORPORATION****HEF-NORTHWEST PROPERTIES VI, INC.**

The undersigned does hereby act as incorporator in adopting the following Articles of Incorporation for the purpose of organizing a corporation for profit, pursuant to the provisions of the Florida Business Corporation Act.

**FIRST:** The corporate name of the corporation (hereinafter called the "Corporation") is HEF-NORTHWEST PROPERTIES VI, INC.

**THIRD:** The number of shares that the Corporation is authorized to issue is 10 shares of Common Stock, no par value.

**SEVENTH:** The duration of the Corporation shall be perpetual.


