Attachment to Certificate of Incorporation of Empty Ventures, Inc.

The total number of shares of all classes of stock which the Corporation shall have authority to issue is 110,000 of which 100,000 shares of par value .001 per share shall be designated as Common Stock and 10,000 shares of par value .001 shall be designated as Preferred Stock.
