**ARTICLES OF INCORPORATION
OF
GCFS HOLDINGS, INC.**

In compliance with the requirements of the Florida Business Corporation Act (the "FBCA"), the undersigned hereby acts as an incorporator in adopting and filing these Articles of Incorporation.

ARTICLE I: NAME

The name of the corporation shall be GCFS Holdings, Inc. (the "Corporation").

ARTICLE II: INITIAL PRINCIPAL OFFICE

The street and mailing address of the initial principal office of the Corporation is 11840 Lacy Lane, Fort Myers, FL 33966.

ARTICLE III: PURPOSE
