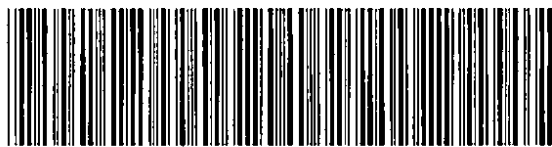

The Articles of Incorporation for this Florida corporation were filed on November 4, 2019, effective November 1, 2019, and assigned Florida document number P19000085375. Pursuant to the provisions of Section 607.1006, *Florida Statutes*, T & G Roofing Company, Inc. (the "**Corporation**") adopts the following amendment to its Articles of Incorporation:

1. Amendment to Article I, name of the Corporation. The new name of the Corporation is Trust Roofing, Inc.
2. The amendment was adopted by the board of directors on May 5, 2022, and subsequently adopted and approved by the shareholders on May 5, 2022 through unanimous written consent. Pursuant to Section 607.1003, *Florida Statutes*, the number of cast for the amendment by the shareholders were sufficient for approval.
