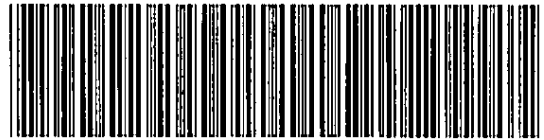

INDEMNIFICATION

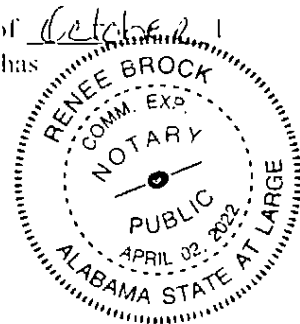


