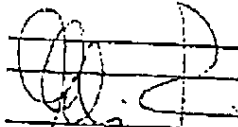
### **PREEMPTIVE RIGHTS**

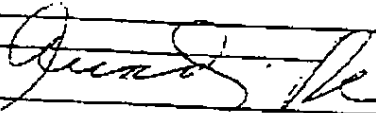
ARTICLE XI
